Violation #47. Food & non-food contact surfaces

Repair leak at walk-in cooler fan pipe. Observed plastic tray on rack under walk-in cooler fan collecting water drops.

CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.

Violation #56. Ventilation & lighting

Increase light intensity inside walk-in freezer. Light intensity shall be at least 108 lux (10 foot candles) in walk-in refrigeration units. Light intensity inside walk-in freezer, at food racks located on back of the unit was measured at 1 foot candle.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
